




Odour Monitoring using Enviro-Suite Software




Likely Originated from SMC

The trajectory generated by Enviro-Suite aligns with the location of the stack.



Possibly Originated from SMC

The trajectory generated by Enviro-Suite is close to aligning with the location of the stack.



Probably did not Originate from SMC

The trajectory generated by Enviro-Suite is not close to the stack but direction of the trajectory is towards SMC.



Did Not Originate from SMC

The trajectory generated by Enviro-Suite is clearly not in the direction of the stack.

Alternative Low Carbon Fuels










ALCF Plastic

St Marys Cement started using ALCF in the process in May.

As of August 31st SMC has used 329 tons of wood and 2658 tons of plastic as Alternative Fuels.





SMC has consumed 140 trucks of plastic and 19 trucks of wood Alternative Low Carbon Fuels.

According to Statistics Canada in 2019 the average Canadian disposed of 105 kg of plastic. Year To Date the quantity of plastic used

as ALCF at SMC is the equivalent of 25,314 Canadians' plastic.











Questions Brought Forward in Advance

St Marys Cement Plant and the Community Liaison Committee received an email from a resident who expressed concerns about noise and vibration perceived at their home. The resident has contacted the Community Liaison Committee multiple times between 2020 and 2023, and the CLC has discussed the concerns at various CLC meetings. Third party noise consultants have indicated that there is no correlation between cement plant operations and the resident's concerns.

The CLC was formed to address concerns related to operations of the facility however testing indicated the concern did not originate from SMC, therefore the email has been shared with CLC Members but will not be reviewed at this meeting.
