

The trajectory generated by Enviro-Suite is close to aligning with the location of the stack.


Probably did not Originate from SMC



St Marys Cement started using ALCF in the process in May 2024. As of May 31, 2025 SMC has used 1607 tons of wood and

13,670 tons of plastic

as Alternative Low Carbon Fuels.



Since May 2024 St Marys Cement has used 647 trucks of plastic* and 57 trucks of wood* as Alternative Low Carbon Fuel.

According to Statistics Canada in 2019 the average Canadian disposed of 105 kg of plastic.





Truck Traffic Impact from ALCF









